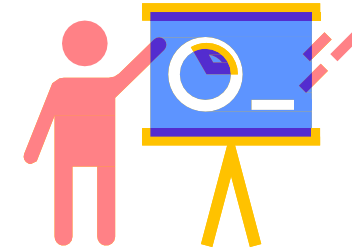

## OTHM Regulations



**OTHM** is a UK-based awarding organisation that is regulated by the Office of the Qualification and Examination Regulation (Ofqual). Ofqual is a non-ministerial government organisation that regulates qualifications, examinations and assessments in England. Ofqual collaborates closely with the UK government and Department of Education on general qualifications, such as GCSEs and A Levels. As an independent regulatory body, Ofqual is responsible for ensuring the integrity and standards of the qualifications. It reports directly to the UK Parliament. OTHM holds a prestigious status as a full member of the Federation of Awarding Bodies (FAB).

## Is OTHM qualifications/certifications acknowledged by MQA?

OTHM qualifications are not affiliated with local accreditation bodies such as the Malaysian Qualifications Agency (MQA) or the Malaysian Board of Technologists (MBOT). As such, they are not subject to local accreditation under these institutions.

However, learners who hold OTHM qualifications may apply to pursue further education at overseas institutions, subject to the entry requirements of their chosen universities. Applicants are required to fulfil the academic and admission criteria set by the respective international institutions.
